In the name of God Amen. I Robert Wakefield of Brushvalley Township Indiana County, being in good health of body and of sound mind necessary and disposing memory praised be God for its same such being desirous to settle my worldly affairs while I have strength and capacity so to do, do make and publish this my last will and testament First and principally I commit my soul into the hands of my Creator who gave it and as to my worldly (?) I do dispose of them in the following manner. Firstly. I give and bequeath to Francis Killen now living with me my farm now situate in Brushvalley now situate in Brushvalley adjoining lands of Edmund Page Stephen Adams and (?) one good team of hoises one wagon and other farming utensils sufficient for carrying on the farm on these conditions. That is, by paying eight hundred dollars, one hundred each year for eight years after my decease and if these eight hundred dollars is not paid at the end of eight years after my decease, The land shall then be sold and these eight hundred dollars he applied as shall be hereafter disposed of and the balance of the money will remain for the said Francis Killen I give and bequeath unto Martha Killen two cows, one walnut bureau and one bedstead and bedding. I give and bequeath unto Sarah Eliot my granddaughter three hundred dollars in money to her paid two years after my decease two cows one Maple bureau one bedstead and bedding one side saddle and one clock. I give and bequeath to my grand children, heirs of James Wakefield, John Wakefield and Thomas Wakefield eight hundred dollars of the money that comes out of the land to be paid as it comes due. To share alike and alike I give and bequeath unto my granddaughter Mary Johnston one hundred dollars to be paid three years after my decease and if there is any money left after paying all necessary expenses it shall be equally divided between Mary Johnston Sarah Eliot and Margaret Wakefield. And I do hereby nominate, constitute and appoint Abraham Wolf of Brushvalley Township and Stephen A. Johnston of Armaugh (sic) in Wheatfield Township executors of this my last will and testament and declare this to be my last will and testament. In witness whereof I the said testator Robert Wakefield have to this my last will and testament set my hand and seal this 10th day of December AD 1862.
